Liability Waiver, Health Certification and Photo Disclaimer

Payment: *I agree to pay the rates that are in effect at the time my pet is left at Paws 4 Fun. I am aware that extra charges may be incurred, and I agree to pay them at the time of pick up. This would include, but not limited to, Paws 4 Fun food provided meals, late or early pick up/ drop off, training, emergency services, and if my pet(s) needs to be moved from regular play groups to one on one.*

Medical: *I understand that all pets entering Paws 4 Fun will be examined for fleas, warts, staph and any other condition that can spread. If any are found, my pet will not be allowed to enter until proper treatment has been started by my veterinary clinic and is no longer contagious.*

I certify that my pet has not been ill with any communicable condition in the past 15 days.

I understand that my pet must have vaccines administered by a veterinarian at least 72 hours prior to being allowed entrance to the park.

I understand that although Paws 4 Fun requires my dog(s) Bordetella vaccination to be current; there are many ways that kennel cough or infections tracheobronchitis can be contracted. I understand that other viral and bacterial sources may not be covered by the vaccination. I waive Paws 4 Fun from being liable if my pet(s) develop this after being at their facility.

I understand that if my pet(s) has or develops a cough or appears sick or requires medical attention while being at Paws 4 Fun, my pet(s) may be asked to be immediately seen by a vet, quarantined, or removed from the facility. I understand that any charges incurred by this will be my responsibility.

Safety: *I understand that for the safety of people and animals, no person under 16 years of age will be allowed into the park. No person under 16 years of age may enter the park without an adult present.*

Photos: *I understand that Paws 4 Fun will sometimes take photographs of my pet or myself for purposes including web content, publicity, or advertising.*

Liability Release: *I understand that Paws 4 Fun will exercise all due diligence and care while in possession of my pet(s). I waive and release Paws 4 Fun and its employees, owners, and agents from any and all liability of any nature for injury or damage, including that which may result from action of any dog including my own. I expressly assume the risk of such damage or injury while my dog participates in or attends any function of Paws 4 Fun, while on the grounds or the surrounding area. I understand that animals are at times unpredictable and may cause damage to themselves, other animals, humans and property. I realize that by signing this Paws 4 Fun is not liable for all losses, expenses, and or liabilities. I have read and agree to the terms of this contract. I warrant that I have the authority to represent all other owners of this/these pet(s) by signing this contract.*
